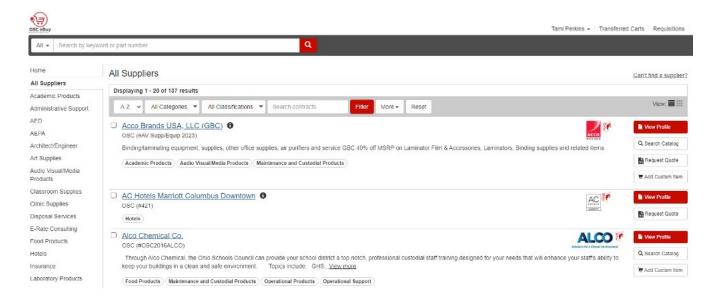
#### **Getting Started:**

- 1. <u>Click here to self-register</u>
- 2. Click on the link in your email.
- 3. Begin shopping in our eBuy Marketplace!
- 4. Click to watch short video
- 5. Remember, this is a live site -Any orders submitted to a vendor will be placed!

Note: Your district has an approver assigned to it, typically a Treasurer or Business Manager, which will need to approve the orders before they are sent to the Vendors. The approver will receive an email notification to review, approve, deny or modify the order before processing the order to the vendor.

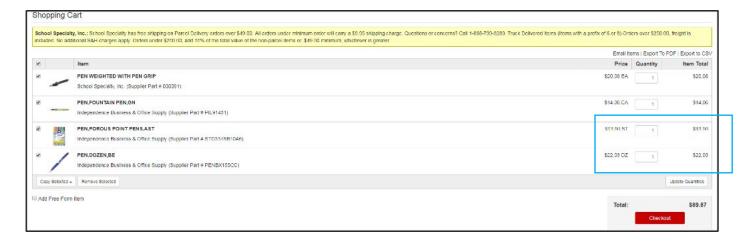
#### Searching for items:

Searching in the marketplace can be done by searching All, an Individual Category or an Individual Supplier.



#### **Shopping Cart:**

1. Once you have an item in your Shopping Cart, Yellow Banner messages may be displayed for some suppliers on the top of the cart. These banners will help highlight any special conditions that may apply to purchasing from that supplier.



- 2. After you have clicked Checkout, you will be taken to the Checkout page to finalize your order.
- 3. Confirm your Shipping and Billing Address or add them.
- 4. Enter a purchase card or Purchase Order number for the Payment Option. When multiple vendors are in your Shopping Cart, you have the option to enter a different PO number for each, or the Marketplace will add a "-1, -2," etc. for each different supplier if only one PO number is entered.
  - Note: the full 16 digit purchase card numbers are not transmitted through eBuy to the vendor for security reasons. The vendor should contact you for the full purchase card number after receiving your order.
- 5. When all of the information is correct, click Place Order. This will send your requisition to your approver. Or, you can Save your Requisition/Order for a later time or to print. You can find your saved orders in the Requisitions menu. (Note a Saved Requisition is not a placed/completed order. The order will not be sent to an approver or placed until you click "Place Order.")
- 6. Once you Place Order, your approver will be notified via email that an order is ready for review. Once they approve the order, it will be sent to the vendor(s) through the marketplace and your order is placed. You will receive a confirmation email when this happens. If you do not receive a confirmation, or your approver does not receive the email notification, please check the email's Spam folder for emails from "noreply@equallevel.com."
