- D) Approval of extension of Paper Award with ODP Business Solutions (formerly Office Depot) until December 31, 2023, with price increases submitted quarterly if increased by the manufacturer.

- E) Approval to correct the price on the OSC Farm to School Products and Non-Local Products Award with Creative Gardens, due to a submission error, for minimally processed and 3-4" fresh cut celery sticks from \$1.05/5# to \$10.50/5#. (Exhibit F)
- F) Approval of a price increase for peaches on the OSC Farm to School Products and Non-Local Products Award with Creative Gardens, from \$30.55/25# box to \$36.00/25# box, due to supply shortages.

- G) Approval of Hershey's Ice Cream price increase for 3 oz. plastic dessert cup, 4 flavors offered, from \$15.84 (\$0.33 each) to \$18.48 (\$0.39 each) for 48/case effective July 1, 2022. (Exhibit G)
- H) Approval of increase in pricing on the OSC Farm to School Products and Non-Local Products Award with Terry Thomsen LLC, due to substantial increases in supply and facility costs for 1 oz. wrapped pizza bagel from \$33.00 to \$37.94 per case 60, 1 oz. pizza bagel from \$31.80 to \$35.29 per case 60, 1 oz. cinnamon bagel from \$27.00 to \$26.47 per case 60, and 2 oz. pizza bagel from \$69.00 to \$70.59 per case 60.
